A member of the Fire Service attended the meeting and outlined some possible project ideas. The Fire Service are now getting more involved in road safety issues and may be able to help with the installations of the Speed Indicator (SPiD) sign. Installations had stalled due to insurance issues for volunteers. The sign was bought by residents through the Ward Opportunity Fund, however, the residents didn't have insurance to install the sign so the sign was returned to the Borough Councilors. Lancashire County Council would take the sign but couldn't guarantee it would remain in Hapton. The Fire Service will check if they could offer support to installing the sign and provide a report back.

The 20mph zone outside the school is being ignored, it was suggested that a lit sign may be more efficient and the County Councillor is to be asked if one could be provided. The Police will also be contacted about more enforcement.

There were no further public questions.

The Parish Council then gave it's condolences for the young lady who tragically died in a house fire in the village.

At this stage it is unsure if the PCSO will be replaced and the sergeant is to be asked if a replacement will be provided.

The Heritage Group is waiting for the insides for the information boards although a couple have now been approved and will to be installed very soon. The Hapton Stone sign has been installed and flowers will be planted in the Spring. The group is to receive tuition on voice recording editing and have visited Sir Simon Towneley to view some old maps. A Christmas event for the group is being held on Tuesday 10th December at the Hapton Inn after the meeting.

The next Lancashire Association of Local Councils (LALC) is to be held on the same day as the Christmas Light switch on event.
