It was reported that a footpath is overgrown through the caravans and parks have not trimmed paths for a number of years, Councillor Cunningham agreed to contact the Borough Council. East Street to Junction 9 along the side of the canal needs to be tidied by the County Council (footpath 52). The Heritage Group have arranged for some footpaths to be cleared and a Lengthsman scheme was suggested next year if funding through a precept is available. A possible precept is to be discussed at a future meeting and residents will be consulted.
