Parish Council Agenda

Councillor Birbeck opened the meeting and welcomed everyone.

14/15/133 Apology for absence and reasons given

Apologies were submitted on behalf of Parish Councillor Jill Charlton and Borough Councillor Joanne Greenwood.

14/15/134 Declarations of Disclosable Pecuniary Interest / Code of Conduct

There were no declarations of disclosable pecuniary interest.

14/15/135 RESOLVED: That the meeting would be adjourned to welcome comments from members of the public.

A resident representing the Padiham Community Action group attended and outlined that the group was raising awareness of the Community Plan and how to object, the main objections were to the proposed extension of the Industrial sites. The group had

a drop-in meeting at Padiham Town Hall and provided the Council with a list of objections. The group has over 150 members, a Facebook page and website. The Borough Council Committee considering the proposal only has 1 Padiham Councillor. The Council agreed that there were enough Industrial Units in Hapton and supported the group's objections.

A resident attended and thanked Borough Councillors Jean Cunningham and Joanne Greenwood for all their help with complaints about the wind turbines. The residents outlined that they were considering putting in for Planning Permission for a barn and shippen conversion and wanted the Parish Council to be aware. This would help compensate them for the loss of value to their property due to the turbines. Some initial drawings were presented that outlined a proposal for 3, 2 bedroom affordable properties, which would also encourage local people to remain in Hapton. The residents were thanked for attending.

There was no Police Report though it was noted that cars had been keyed on Simpson Street after the football on Saturday, it was advised that this should be reported to the Police. Cars are also meeting on St. Margaret's car park then speeding up Manchester Road. There was no County Councillor report.

The Borough Councillor reported she and Borough Councillor Greenwood were working on a funding bid for football changing rooms. They were still waiting for the dog fouling signs and a list of places was requested and a further 100 dog bins are to be provided. A roof for the bandstand in Memorial Park is also being pursued. A list of 19 places for dog signs was provided.
